

EXECUTIVE SUMMARY

The fourth quarter of 2016 produced a total of 67 observations (Kane County: 44 reports; Kendall County: reports). Observation outcomes breakdown as follows:

Kane County:

- 22 cases were continued.
- 9 cases dismissed, most due to victim or witness continuing to not appear.
- 5 cases resulted in a guilty verdict
- 1 case resulted in a not guilty verdict
- 2 motions were granted
- 2 motions were denied
- 3 cases no action was taken

Kendall County:


- 11 cases were continued mostly due to victim or witness was not present
- 5 cases were dismissed due to victim or witness continuing to not appear
- 3 cases guilty verdict, including one plea to common battery
- 3 cases not guilty verdict
- 1 motion was granted

Judge does a good job of managing time. Delays most often caused by ASA staff not being prepared.


The presence of translators makes it difficult to hear the proceedings. Due to simultaneous talking.

Judge threatened one attorney with jail if his behavior did not improve.


Judge asked observer if he has any questions at the end of the session.

25 minute recess taken due to no shows.


High school students toured the courtroom and spoke with Judge.


A fight occurred outside the courtroom. Security arrested one person.

When a change is made to the docket posted outside the courtroom no explanation is given.
