

EXECUTIVE SUMMARY

The third quarter of 2017 produced a total of 59 observations (Kane County: 32 reports; Kendall County: 27 reports). Observation outcomes breakdown as follows:

NOTE: The main obstacle to Court Watch Observers in Kane County continued to be the absence of an effective way to identify pending domestic bench and jury trials. Late in the quarter a file of pending cases was received from the County. The assignment of felony domestic cases to multiple courtrooms continues to make it more difficult for Observers.

We receive a monthly update of domestic trials from the Kendall County States Attorney's office. Continuation dates are reported by observers, so these cases can be tracked and observed when possible.

Kane County:

- 17 cases were continued.
- 4 cases were dismissed, mostly due to victim or witness continuing to not appear.
- 5 cases resulted in a guilty verdict, 1 of these was pleaded down to common battery.
- 0 cases resulted in a not guilty verdict.
- 6 OP requests were granted.


Kendall County:


- 12 cases were continued mostly due to victim or witness was not present.
- 4 cases were dismissed due to victim or witness continuing to not appear.
- 8 cases resulted in a guilty verdict, 5 of these were pleaded down to common battery.
- 1 case resulted in a not guilty verdict
- 2 OP requests were granted.

Kept everything moving very fast.


When translator is present audibility is not as good.

created a better performance by the Judge. Encouraged me to return.


Extremely loud today due to attorneys talking with clients in court.
